## President's Message

My Athena Sisters, as you read this message we're on the verge of a new calendar year; however, as I put pen to paper - actually, more correctly, keyboard to computer - it's still 2016 with Christmas, Hanukkah and the New Year to come. It indeed is a lovely time of the year. Here's to family and dear friends! And whatever the New Year holds, may it be a healthy, safe and joyous one for each of us, our loved ones and our beloved country.

By nature I am the glass-half-full person, the optimist for whom tomorrow always hold promise. I believe strongly that my optimism has been a key to my positive emotional and physical health. I am adaptable and wired to navigate life's strong head winds. I think overall, on a macro level, our country has a similar DNA. This was the sense I had last month, when I wrote how encouraged I was by the initial post-election comments. Several weeks later my optimism endures and this is thanks in no small measure to the gracious words of President Obama himself, who gives lie to the notion that rancor, divisiveness, partisanship, are - and forever shall be - the order of the day, to-wit: "The point though is that we all go forward with a presumption of good faith in our fellow citizens, because that presumption of good faith is essential to a vibrant and functioning economy. That is how this country has moved for 240 years."

Regardless of which side of the political aisle you find yourself, these comments forging unity and promoting coalescence should give us all confidence that our great county shall move inexorably forward through a peaceful and orderly transition of power, its vibrancy and freedoms in full bloom.

November 7th, the day before the election, America lost a true giant; a giant not because this person stood just north of six feet tall or became the first woman to serve as Attorney General but a giant because of her unwavering principles, unassailable ethics, steely resolve and the-buck-stops-here honesty. Rest well, Janet Reno. Thank you for service to country and to the Sunshine State. We Athena women are enriched and ennobled by your trailblazing work.

President **Jeanne Tate** created the Mentoring Committee to provide outreach opportunities to students, graduates and Young Women of Promise ("YWP") participants to foster professional and educational growth, career development and personal fulfillment. ## President's Message

The New Year is in full swing, the college football championship shined its brightest light on Tampa Bay—we looked marvelous!—the new President is in his first 100 days, movies are front and center, an award season is upon us (I commend each of you to take in *Jackie*, *Hidden Figures*, *La La Land* and *Lion* as these films have outstanding, Oscar-worthy, female acting performances) and our busy lives just keep going on and on and hopefully all for the good.

As many of you know, I was raised in South Florida, Oakland Park, Broward County, to be exact. Last month I wrote warmly of Janet Reno and how her passing stirred my treasure trove of memory for that part of Florida I called home. When we recall our childhood, we conjure up images and hearken back to many special, sometimes magical, places—many of which are in a lobe of our brain—but, amazingly, race back into focus when we walk these same grounds or have occasion to access them as adults.

One magical place for me growing up was our local airport where I used to gaze skyward at massive birds in the sky, wondering how something that enormous gets off the ground and, equally puzzling, how it ever lands safely. Moreover, our airport was where my family and I greeted loved ones who just arrived from the sky, thanks to these big birds, and where we then chatted excitedly at baggage claim, waiting impatiently to lug those large Samsonites (sans wheels back then) to our car.

It is against this backdrop that I took in last month's horrific shootings at Terminal 2 of the Ft. Lauderdale-Hollywood International Airport. This was still another unspeakable, random act of violence where sweet innocent people collided with a person bent on mayhem and murder, and all in a venue where I have been all my life, where my family flies into and out of and will continue to do so and where many of you and your loved ones pass through when flying as well.

This event is not hitting "too close to home"; it is as if it has hit home to an aviation location near and dear to me and many of you, I am sure. These grieving families now must navigate a shattered landscape they never envisioned. And for those of you, like me, who know this airport well, this event has bulldozed a searing image we never imagined and re-enforced for us just how fragile and fleeting life can be.

This is exemplified as well by the December passing of Debbie Reynolds and Carrie Fisher one day apart. Mother-Daughter bonds are extraordinary, they are timeless, indeed they endure-no matter their tumultuous dynamic. Given when we grew up, what captivated us could have been Debbie Reynolds gliding along with Gene Kelly in *Singin' in the Rain* or Carrie Fisher as Princess Leia in *Star Wars*, whose strong female character was one we strove to emulate. Maybe we had the privilege to enjoy both of these screen luminaries during their amazing time in the public square.

Of course, neither was without her foibles, weaknesses, personal challenges, all of which were on display for the public, like it or not, fully illuminated. And how many of us can say our relationship

with our husband inspired him to pen a song, let alone an album, but Carrie Fisher can; just give a listen to Paul Simon's *Heart and Bones*.

Regrettably, work out of town precluded my attendance at January's "New Year, New Hope" luncheon which featured our own **Jan Roberts** but thanks to **Tina Tenret**, I understand Jan's captivating presentation not only was overwhelmingly well received - and by a record number of attendees who showed their appreciation to Jan with a standing ovation - but also that Jan's remarks were made all the warmer by **Lorna Taylor's** personal, insightful introduction.

Jan crisscrossed the country on a 3-month journey of 13,000 plus miles, along the way interviewing inspiring, passionate people making deep seated changes in their communities. In honor of Black History Month, the Bonus Committee has planned a very special outing to the Bealsville community in Plant City where we will hear from local folk artist Ruby C. Williams. The event will take place on Saturday, February 25, 11 a.m. to 1 p.m. at the historic Glover School and Museum located at 5104 Horton Road, Plant City 33567. Bealsville is a historic African American town that was founded by five freed slaves, one of whom was Ms. Williams' great-grandmother. Ms. Williams' work, which has been exhibited at the Smithsonian, features brightly-colored paintings that draw on her heritage and the role that farming has played in her family's history. Original pieces will be available for purchase via cash or check at the event and a soul food lunch will be served. We hope you'll join us for this special Bonus open to both members and guests. Additionally, did you know that several of our fellow Athena members are pioneers in their professional fields and living examples of black history? Here are some highlights for your review:

• **Simone Gans Barefield** has owned and operated her own nationwide executive search and consulting firm for 30 years. Simone also was the sole African American woman to serve as an organizing director of NorthStar bank in Tampa.

## February Bonus continued

- In 1989 **Bonnie Carr** established her own CPA firm in Chicago where she trained and endorsed at least six other African American accountants to become Certified Public Accountants and maintained an active practice until 2009. Ms. Carr also was the first and to date only African American female to serve as Chief Financial Officer for Hillsborough Community College which served over 40,000 students and had a total budget in excess of \$400 million during her tenure.
- Hon. Marva Crenshaw is the third African American and second African American woman to sit on Florida's Second District Court of Appeal. Judge Crenshaw also is a founding member of the George Edgecomb Bar Association.
- Fentrice Driskell was the first African American valedictorian at her high school and the first African American woman to be elected as President of Harvard's student government. At the time she made partner at the Carlton Fields law firm, she was one of only six African American women to have done so in the firm's history.
- **Doretha Edgecomb**, a lifelong educator and champion of public education, was only the third African American and the second African American female to be elected to the Hillsborough County School Board. Mrs. Edgecomb also served for three terms as a director of the Children's Board of Hillsborough County and is the honorary chair of the George Edgecomb Society at the Moffitt Cancer Center.
- The first African American lawyer in Polk County, **Senator Arthenia Joyner** also was the first African American female attorney in Hillsborough County, Governor's appointee to the Hillsborough County Aviation authority, member of the Greater Tampa Chamber of Commerce, officer and board member of the Hillsborough County Bar Association, and chair of Bay Area Legal Services. Senator Joyner was the first African American female elected to the Florida House of Representatives and the Florida Senate from Hillsborough County and the first African American female elected as Democratic Leader of the Florida Senate. She also is the first African American member and a founding member of the Tampa Bay Partnership and the first African American female chair of Bay Area Legal Services.
- Hon. Mary Scriven was the first African American woman partner at the Carlton Fields law firm. Judge Scriven also was the first African American woman to sit on the federal bench in Florida and only the second to serve the federal judiciary in the Eleventh Circuit which covers Florida, Georgia and Alabama.
- **Dr. Juel Smith** is the first African American woman to establish an official Institute at the University of South Florida: The USF Institute on Black Life. She founded the Center for Africa and the Diaspora at USF and established a USF and African Agreement with Gabon, Africa. She also envisioned and established the USF Women in Leadership & Philanthropy Program and served as its Founding Executive Director. A native Oklahoman, she was a member the first Class to integrate Sapulpa High School (1962). Dr. Smith also is proud to have been elected the first African American woman to serve as president of the Athena Society.
- **Dr. Miriam Stamps** was the first African American female to be tenured in the College of Business at the University of south Florida, the first (and only to this point) African. American department chair in College of Business at USF. Dr. Stamps also was selected to be in the Hall of Fame of the PhD Project, a national group that encourages African-Americans, Hispanics and Native Americans to pursue PhD degrees in business-related fields, for her contributions over the years in accomplishing that goal.
- Hon. Barbara Twine Thomas was the first African American judge to win a runoff in a general election in Hillsborough County and is only the second African American circuit court judge to be elected in Hillsborough County.

Next week's program, spearheaded by the Community Action Committee, will explore the challenges and plans for public transportation in Hillsborough County. While most of us may not use the public transportation system, it is an integral part of the quality of life for those who do.

CEO of HART, Katharine Eagan will address concerns for accessibility and availability of service for women commuting to work and day care as well as for the elderly and disabled. She'll also share ideas to accommodate the anticipated growth in specific areas of the county.

Katharine Eagan was named one of the Business Women of the Year by the *Tampa Bay Business Journal* in 2016 and is the only female leader for transportation in our community.



## President's Message

As I compose my monthly President's Message for March, I do so in anticipation of Athena's February 25th Black History Month celebration at the Glover School and Museum whose history as a school dates back to 1873. The Glover School is listed on the United States National Register of Historic Places and is included in Florida's Office of Cultural and Historical Programs. While supposedly in Plant City, in actuality the Glover School is in Bealsville, one of America's first African-American-founded communities dating back to its establishment in 1865 by twelve (12) freed slaves.

Our Athena Bonus - which will take place this Saturday - will be a repast melding and blending all the delicious flavors for which soul food is known and beloved. The luncheon also will have given those of us attending the distinct privilege to meet, listen to and admire the artwork and business acumen of Ruby C. Williams, a fourth generation Bealsville native whose great-grandmother, Mary Reddick, was among Bealsville's original founders. Ruby is a self-taught painter, children's book illustrator (*I am Ruby*), business owner of a self-built fruit and vegetable market on her property and wordsmith whose "sayings"-like "Hey, This is My Life"-appear on many of her paintings. Ruby is the recipient of the 2005 Florida Folk Heritage Award and was one of the featured artists in the Smithsonian's Anacostia Museum exhibit titled "On Their Own-Selected Self-Taught Artists." Ruby's art and produce business also were spotlighted by Florida author and native Jeff Klinkenberg in his book, *Seasons of Florida*.

And on the important topic of Black History and Black History Month, what I believe history shall record as a watershed event in the African-American experience in America - and what I hope shall become an integral part of Black History Month going forward - is the Sept. 24th opening of the Smithsonian Institution National Museum of African American History and Culture. Prominently situated just to the east of the Washington Monument, the Museum, an architectural marvel of a building comprised of three inverted trapezoids, is a testament to the vitality of our country's African-American brothers and sisters.

Finally, on Feb. 26th movie history could be made and, if so, also could figure prominently in Black History Month going forward. Films focusing on the African-American experience, like *Moonlight*, *Hidden Figures* and *Fences* already have been honored with a slew of Academy Award nominations. Each is nominated for Best Picture, Supporting Actress and Adapted Screenplay and have been showcased in many pre-Oscar award season events. Moreover, Ruth Negga of the film *Loving* is nominated for Best Actress and three (3) African-American-themed films - *I am Not Your Negro*, *O.J.: Made in America* and *13th*- are nominated for Best Documentary Feature. Plus the Oscar for Best Director could make history if bestowed upon *Moonlight's* Barry Jenkins. These nominations - let alone that any of these fine films should win - not only put to be bed (hopefully forever) the shameful stain that was the not-so-long-ago "Oscars So White" but also give voice to other aspiring and established African-American artists and give Black History Month more prominent milestone(s) to highlight in the years ahead.

## **Dottie MacKinnon Woman of Influence 2017 Award**

#### A Refocus on Women

March is designated as Women's Month. With this in mind, the Community Action Committee is encouraging us to refocus on women and the purpose of Athena as we serve in our communities. The recent march in Washington, D.C. and other cities was a reminder that many of the issues that prompted the formation of Athena still persist today. While there were many different groups involved and many agendas presented, there was an overall and consistent interest in refocusing on women's issues. To support our refocusing and recollection of positions that Athena has approved on several public issues, following is an abbreviated list of those positions: (The full list is published on the Athena website.)

**Affirmative Action** - The Athena Society favors ongoing action to remove barriers and secure access to the full range of educational, employment and economic opportunities for all people.

**Choice** - The Athena Society supports the position that the decision to have an abortion is a personal one. Further, this decision should be an informed choice. Consistent with this position, Athena opposes any governmental interference with an individual's right to decide when or if she should bear children.

**Day Care** - Concerned with the ongoing need for day care programs outside the household and schools and an anticipated increase in those needs due to our economy, where it is common for both parents to work and for children to grow up in one-parent families.

**Educational Funding** - Recognizing that the strength of our democracy is based on the strength of our educational system, the Athena Society supports fully funding programs that allow all students the ability to maximize their potential; and providing resources for teacher salaries that attract and retain the best and brightest.

**Equal Rights Amendment** - The Athena Society supports the ratification of the Equal Rights Amendment to the Constitution of the United States.

**Indigent Health Care** - The Athena Society supports access to quality, uninterrupted health care for all citizens.

**Non-Violence** - The Athena Society supports a stand against violence through activities and the dissemination of information aimed at changing this course.

**Pay Equity** - Athena Society believes that a system of pay equity or comparable worth should be instituted in government, industry, and the professions in all positions which lend themselves to objective ranking.

**Tolerance** - Concerned with acts of hatred and prejudice in our community, the Athena Society rejects activities that promote intolerance and dissension; embraces policies and actions that value and promote diversity, understanding and the acceptance of differences in race, religion, ethnicity, sexual orientation and gender; and promotes the eradication of prejudice and bigotry whenever and wherever it is encountered.

## President's Message

Like many of you who attended our March luncheon, I have been concerned — and that may be too mild a term — by the absence of foresight and vision displayed by our many of our elected officials in the arena of public transportation. That is why I was so interested to hear our guest speaker's luncheon remarks and, indeed, HART CEO Katharine Eagan gave us a litany of options to consider. Here's to an expanded funding for HART and for the similar entity across the bay, the Pinellas Suncoast Transit Authority (PSTA).

Speaking succinctly and passionately, Katharine laid out a road map for the public transportation path forward and it is one Katharine suggests, now more than ever, must include a Tampa Bay region focus rather than a pure local-focus, which historically has been the mantra, but which direction clearly is shifting, an encouraging signal in and of itself. While many of us may not utilize public transportation day-in and day-out, it nonetheless is the transportation lifeline for many — most of whom are women — and it not only must be *affordable* but it also must be *accessible* and *available*, the AAA of public transportation.

Our elected officials, our transportation experts and all of us motivated to see change need not re-invent the wheel. Other cities have embraced the challenge that is public transportation in new and creative ways while still maintaining the tried and true options, even expanding them. Let's look once again at options that are over and above the bus, especially the mega bus. Orlando has Sun-Rail, South Florida has Tri-Rail and Miami its over-ground Metro system. Tampa has room for rail on I-4 and on I-275 between the airport and downtown. Moreover, Tampa has its trolley system and its funding sources, best use, even expansion, are on the front burner.

How do we make the Tampa Bay Cross Bay Ferry - which is a lovely and leisurely excursion - an affordable and viable transportation option? Take a virtual or, better yet, actual ride aboard Seattle's Washington State Ferries, NYC's Staten Island Ferry or San Francisco's Golden Gate Ferries to get a glimpse of what could be for the Tampa Bay area.

Whatever will be from among the plethora of transportation options available, our citizens must have options to get to their jobs, to their child's daycare, to their shopping venues, and it must not be a daily, hours-long odyssey. The hope is that when that single, working mom, child in tow, sets out for the bus, trolley, ride share vehicle, subway, light rail, train or ferry she safely and timely arrives at her final destination with an *AAA* experience.

BTW, native Florida daughter and loyal Florida Gator that I am, nonetheless, I salute the FSU film school and its proud alum, Barry Jenkins, a native Florida son, whose exquisite film, *Moonlight*, received the Academy Award as Best Picture for 2016 and who, along with playwright, Tarell Alvin McCraney, also a Florida native, received the Academy Award for Best Adapted Screenplay for *Moonlight*, adapted from Mr. McCraney's original play, *In Moonlight Black Boys Look Blue*.

# President's Message

It is no easy task to compose a monthly message to such an accomplished and respected group of women. The benefit of being bestowed the literary pen, however, allows me to write about most anything, including things that have struck an unharmonious chord with me personally. I feel compelled to share with you the revulsion I experienced regarding the recent chemical attack in Syria. Like many of you, I am a daughter, mother, grandmother. I consider myself a nurturer and believe in every fiber of my marrow that life is precious. Yet I have lived long enough to have seen inhumanity, cruelty; naïve I am not. Perhaps this banned chemical attack, brazenly undertaken and in violation of treaties and international norms of decency—to say nothing of Syria having pledged to the world in 2013 to do away with its chemical arsenal—shall galvanize the world against this abhorrent practice, bring sanction against those responsible and allow those affected by this horrific event to know that their loved ones did not die in vain. Pipe dream, I hope and pray it is not.

Below you will find comments emanated from Athena's Long-range Planning Committee (LRPC). Athena's long-range planning is vitally important and a solemn responsibility, which your Committee and the Board have embraced whole heartedly. The Committee members have done exemplary work and each deserves our thanks and appreciation, starting with Chair **Mary Gamble** and Vice Chair **Karen Arnold**.

Perhaps the most telling messages heard by the LRPC from the 100+ plus members who have participated in the planning process thus far were found in discussions about Athena's culture and Athena's long term market position summarized as follows:

"Often overlooked is the dual purpose found in Athena's Purpose Statement which describes Athena's shared purpose as both interaction and the promotion of equality and opportunity for women. It is the unique nature of this interaction that Athena members hold dear and describe as a "sisterhood." This always present and unique nature of the organization itself serves as the foundation on which everything else Athena does rest. It must be preserved and nurtured."

"Athena's future as the premiere professional women's group in Tampa Bay depends on Athena taking on greater advocacy and social action."

Another message the LRPC heard from members is that of preserving those programs Athena does well, specifically the Dr. **Sylvia Richardson** Young Women of Promise and the **Phyllis Marshall** Career Assistance Grants. Finally, the LRPC recognized that in order to address these opportunities and challenges over the next five years, Athena will need certain operational and governance capabilities.

Accordingly, Athena's Draft 2018-2022 Long Range Plan which will be distributed to all members early in May has been built around four Strategic Pillars:

- \* Membership
- \* The Integration of Advocacy, Social Action and Lunch Programming
- \* Scholarship Programs
- \*Organizational Operations and Governance.

## Phyllis Marshall CAG Program

This was an exceptional year for the Marshall Grant Committee. As a direct result of your generosity, we are providing grants to ten striving and deserving women in our community and giving nearly \$13,000 in tangible support to help them meet their educational and career goals. What an outstanding expression of the values of the Athena Society in action and it could not be done without your generosity.

It is fitting that this is the 20th anniversary of the Career Assistance Grant program, which was started under the leadership of **Paddy Moses**, then president of Athena, along with the founding committee members **Nancy Ford**, **Linda Hanna**, **Juel Smith** and **Susan Bucklew** to help striving and struggling adult women establish a more hopeful life for themselves and their families. It was renamed to honor **Phyllis Marshall** and her commitment to women and education.

Each year the Phyllis Marshall CAG Committee reaches out to community organizations and schools to identify motivated and deserving local women struggling to succeed. The women selected to receive awards are amazing. At the awards luncheon this year we will celebrate their strength and resilience – the grit that allows them to persevere in the face of obstacles.

The Marshall grant program has grown over the years in other ways. This year we have two returning award winners, Mary Velasquez-Sullock and Erika Robinson, who are successfully continuing their education. A third woman, Linda Walker, was awarded a Marshall grant in 2015 but was diagnosed with breast cancer before she was able to use it. She is back, cancer free, and ready to pursue her goals. This will also be the first luncheon at which we will have a former award recipient attending as a guest to support a newly selected award recipient. How Athena-like and fitting for this 20 year anniversary.

I could fill the newsletter with their amazing stories but instead I will share just a couple. Khumari Barakzai came to the US from Afghanistan in 2013 as a bride in an arranged marriage. After teaching herself to speak English by watching television, her husband allowed her to attend school at HCC. There she met people who helped her escape from an abusive marriage and plan a different life for herself and her daughter. She is an exceptional student pursuing a degree in computer science with a dream to return to Afghanistan and teach other women that education can be a path to freedom and independence.

Latonya Parker's application was at first confusing. Although she is only 26 years old, she has 6 dependents. Her references explained that she lost her mother in 2013 and her father in 2016, leaving her to care for her son, her siblings and a niece. She maintains a stellar academic record while making sure her sister has an outfit for career day at school and that her siblings were able to visit their father during a protracted hospitalization prior to his death. She assumed this matriarch role with grace, kindness and strength. Her goal is to become a registered nurse.

Twenty-seven women were eligible and deserving of grants this year. The ten women selected for awards are diverse. We have women retooling their skills to compete in today's world of work and young women on the brink of their careers. Although pursuing different goals, they share the characteristics of strength and determination. It is an honor to support their goals. Congratulations, Athena, on twenty years of supporting striving women!

## **Community Action Committee**

#### Unfairness in the Workplace

Shortly after a popular TV personality was recently banished from a major network for improper advances toward women, the *New York Times* published an editorial summarizing some of the continuing and unfortunate conditions facing women in the workforce. As the *Times* pointed out, the high profile dismissal did not occur because of the continuing allegations of sexual harassment by the individual but because the program's advertisers could not afford the embarrassing aftermath and declining revenues.

It's certainly not the first nor will it be the last lament for our hardworking sisters. Nine years after the passage of the Lilly Ledbetter Fair Pay Act, (which **Kathy Castor** co-sponsored), serious inequities in compensation remain. Women are "simply paid less for being female," the *Times* opined.

Some of us recall the arguments for pay equity during the fight for approval of the Equal Rights Amendment during the late seventies. Although progress has been made in closing the salary gap in the years since, a recent analysis by the venerable American Association of University Women provides cause for alarm. According to the AAUW, if progress to close the gap continues at the current rate, women are not expected to reach pay equity with men until 2059!

Here are a few other facts presented in the AAUW analysis. Currently women earn 20% less than a male counterpart even considering education and experience.

- \*Think 80 cents is bad? The gap is worse for women of color.
- \*Women in every state experience the gap. (Florida is actually doing better than most.)
- \*Women face a pay gap in nearly every occupation.
- \*More education helps increase women's earnings, but it still doesn't close the gender pay gap.

Athena is in a strong position to work for improvement. We have held positions on pay equity and comparable worth since our founding. After member surveys were completed earlier this year, members indicated they want more action and visibility on our positions. Why not start with workplace issues, especially compensation?

The AAUW recommends activities like helping professionals learn how to negotiate better salaries and become more aggressive about promotions. Of course, legislative and Congressional action is important too. Convening other interested groups for greater collaboration among like-minded organizations is yet another practical option. There's no time like the present. Let's raise our voices for workforce fairness once more!

#### **Community Action Committee**

We recognize Athena's 40th anniversary this month and celebrate its founding in October 1977. I was asked to provide some historical context for this, especially thoughts related to women and government. The easiest way to do that, I decided, is pull out some of the bulleted news that I used for 1977 in my *Milestones: A Chronology of American Women's History:* 

- When scientist Dixie Lee Ray is inaugurated as governor of Washington, she joins Ella Grasso of Connecticut who took office in 1975 as the first women to serve simultaneously as governors since the 1925 inaugurations of Wyoming's Nellie Tayloe Ross and Texas' Miriam Ferguson. That more than a half-century has passed since the precedent was set is indicative of feminism's slow progress.
- Jimmy Carter, Democrat of Georgia, is the first president to appoint two women to his Cabinet. Juanita Kreps, an economist at Duke University, heads the Commerce Department, while Patricia Roberts Harris, who served as an ambassador under Lyndon Johnson, is chief of Department of Housing and Urban Development. Harris is the first African-American woman on the Cabinet; the first woman was Frances Perkins under Franklin Roosevelt back in 1933. She developed Social Security, minimum wages, and other fundamentals of the modern economy.
- Indiana becomes the 35th of the 38 states necessary for ratification of the Equal Rights Amendment (ERA), but it is rejected in Virginia, Nevada, North Carolina, and Florida. Some of the votes are close: in Florida, it passes the House, but loses narrowly in the Senate. A Tampa senator who campaigned promising support will vote against it in 1982, and the ERA never is ratified.
- Some opposition to the ERA arises because it is increasingly tied to the issue of sexual orientation.
  When Florida's Dade County passes an ordinance banning discrimination against homosexuals, former beauty queen Anita Bryant leads a crusade for repeal. Her faction succeeds but her major advertising sponsor, the orange juice industry, is boycotted.
- A torch is lighted at the historic birthplace of the women's rights movement in Seneca Falls, New York, and is carried by a thousand female runners to Houston, where a giant meeting follows up on the United Nations' International Women's Year.

Those were indeed heady times! Athenians **Betty Castor**, **Helen Gordon Davis**, and **Pat Frank** were strong leaders in the legislature, and women made genuine progress. A backlash came soon, though, as the very next year, 1978, brought the abolition of the Hillsborough County Commission on the Status of Women. Now, in 2017, 37 years have passed since Florida elected a woman as a US senator; we lag behind other states in our failure to elect a woman as governor; and the US Senate never has ratified the UN's 1980 treaty that banned discrimination against women. Forward movement is not inevitable, and freedom is not free.
