I am inspired by the caliber of our membership and you can be sure that your Athena leadership team is energized about the potential in the year ahead.

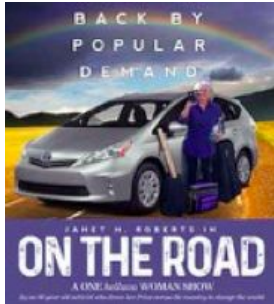

In Remembrance...

Remembering Sylvia Marion Carley, Ph. D.

Sylvia Carley was a Tampa native, who grew up in Ybor City, graduated from Middleton Senior High School and attended Bethune-Cookman College (BA); Clark Atlanta University (MS); the University of Florida (Ph. D.); and Harvard University, where she obtained a certificate in Higher Education Management.

Fifty years ago, in 1968, she was the first African American hired to work at the Department of Health and Human Services. It would become symbolic of her perpetual role as a trailblazer, who was always keenly aware of the needs of her community and her call to serve. Later, Sylvia worked as a college professor, Dean, Vice President of Education and Student Development, and as President of the Ybor City Campus at Hillsborough Community College (HCC); the fifth largest community college in the State of Florida. Significantly, while she was at HCC, Sylvia's responsibilities included serving as the principal investigator for federal grants that focused on supporting first generation college students in their academic endeavors, assisting underprepared students in their pursuit of academic excellence and documenting best practices in the preparation of underprepared students and their success.

Her 50 year career included thirty-five (35) years at HCC; and ten (10) as a retired college administrator and President/CEO of Marion & Associates. Marion & Associates specialized in preparing institutions for accreditation and compliance visits, and in designing and coordinating events that focused on retention and the academic success of underrepresented students. Even after retirement, Sylvia continuously engaged locally and nationally in directing initiatives to enhance the lives of children and adults through education.

Deeply concerned with the plight of African American and Latino males, she founded the national summit, *"Black, Brown and College Bound: Meeting the Challenges of Higher Education."* The summit focused on limited minority access, persistent under representation, and retention in high school and college of African American and Latino males. Over 5,000 participants from more than 25 states attended and participated in the annual national conference. In 2018, the summit was in its 12th year.

Sylvia was empowered through her work and collaborations with other women in many organizations, including the Athena Society; Alpha Kappa Alpha Sorority, Inc. (life member); the National Council of Negro Women (life member); and the National Sorority of Phi Delta Kappa, Inc. She was also a life member of the NAACP.

Sylvia received many awards and accolades, including: the National Award in Leadership by the Chair Academy, a worldwide organization for college and university leaders; and a gubernatorial appointment to the Florida Education Fund Board of Directors. In 2015, Sylvia was installed into the Hillsborough County Commission Women's Hall of Fame.

She was a member of the Beulah Baptist Institutional Church, married to Henry and had 3 children, 6 grandchildren and 2 great grandchildren. Sylvia was a rare and authentic community treasure, who will be missed by many.
