During the annual meeting last June I spoke about focusing on two important goals in the upcoming year. The first goal related to membership. I asked you to identify women in the community who would add to the richness and diversity of Athena. The Membership Committee under the leadership of **Lorna Taylor** recommended eight nominees. At our final meeting on June 5th we will introduce our new members. Please remember to introduce yourself to these remarkable women and welcome them into Athena.

Renee Vaughn graciously hosted the new member orientation meeting at her lovely home in early May. Renee set a high standard for this event with fabulous food and tropical floral arrangements! Thanks so much to Renee for providing a warm welcome to our new members. In addition to funds contributed by Athena members and by the **Beth Waters** Friendship Foundation, 10% of unrestricted funds at the end of the fiscal year are added to the Athena Education Fund at the Community Foundation of Tampa Bay.

This year, our president reports that your contributions and the 10% of unrestricted funds have helped us meet our goal of \$100,000! That's exciting news. It means that we can assist even more women in the coming year and positively impact their lives.

If you recall, at the beginning of the year the Philanthropy Committee issued the Birthday Challenge for 2014. Members' Projects

We will be 3 of 18 people going on a week-long medical mission trip to Honduras in late August. The group has 7 MDs - all women! - and will both staff an existing medical and dental clinic in San Francisco, Honduras, and participate in health fairs in neighboring small communities. At these fairs we do health screenings and give out health kits, so our group is responsible for putting together 1,000 kits to distribute: 500 for children and 500 for adults. These kits include wash cloths, toothbrushes, toothpaste, dental floss, combs, soap, a few band-aids, nail clippers for adults and pencils and pencil sharpeners for the kids.

We'll also be taking some other items - things like crayons, flip flops and eye glasses. We would appreciate any donations, either of the items themselves or money to purchase the items. (The usual plan is to buy the toothpaste and soap there.). If you would like to help support us and this trip with a check, please make it payable to Palma Ceia Presbyterian Church and put "Honduras donation" on the memo line. You may give it to any of us or mail it to the church. If you have items you would like to donate, please contact any of us directly. Thanks in advance. Maybe we will host an Athena bonus after we return and make you look at our pictures!
